

## Can I work in Australia?

If you need help to understand what you can or cannot do on your Student Visa, contact your International Student Support team for more information. Remember, it is your responsibility to understand your visa conditions. Further information is available from:

#### Number of hours I can work?

Generally, coursework students can work a maximum of 48 hours per fortnight when their course is in session, and unlimited hours during holidays and non-compulsory study sessions. A fortnight is defined as a 14-day period beginning on Monday and ending on Sunday.

Students studying for a PhD or Masters by research can work unlimited hours throughout the year.

**Graduate visas:** You may be eligible for a visa that will allow you to stay

and work in Australia after completing your studies. Please also refer to any scholarship conditions regarding working hours. Check your eligibility online for the latest information: homeaffairs.gov.au

# Do I have to pay tax?

Yes. Australian Tax Office (ATO): Phone 13 28 65 or ato.gov.au. You will need a Tax File Number. Apply for one, for free through the Australian Tax Office. Claim your tax back at the end of the financial year in Australia (30 June).

If you leave the country permanently before that date you can claim your tax back early.

## **Superannuation**

If your monthly wage is more than AU\$450, your employer must contribute a specified percentage of your wage into a superannuation (pension) account for you. You will need to advise your employer of your superannuation fund. In most cases, you can access your contributions when you leave Australia permanently, although the contributions will be taxed.

Visit the Australian Tax Office site on ato.gov.au to assess your eligibility to claim your superannuation contributions.

# Cash, ABN and 'contractor' payments

Some employers pay in cash instead of into your bank account. This is okay, provided they also:

- deduct tax from your pay
- give you payslips showing how much tax has been deducted
- pay superannuation contributions on your behalf (if you are entitled to superannuation).

If an employer does not do these things, you may be receiving the wrong pay and superannuation benefits.

Be aware that some employers may incorrectly treat you as a contractor or ask you to get an Australian Business Number (ABN). Having an ABN does not make you a contractor. Only people who operate a business can have an ABN.

If an employer offers to pay you in cash without deducting any tax or paying contributions into your superannuation fund, report them (anonymously) to the Australian Tax Office by phoning 1800 060 062.

Many jobs in Australia are not advertised. This means you limit your ability to get a job if you rely solely on looking for advertisements online or in the newspaper.
