Find your unit and your term. Check your progression plan to confirm which placement units you should be enrolled in, and when. A unit offered in more than one term has a row for each, with different deadlines — it is your responsibility to know your term and to follow that row. If you are unsure, contact [Client Services](#) before you rely on a date.

You must be enrolled in a placement unit by its FTP deadline. Submitting your Fit to Practice requirements is not enough on its own — being enrolled by that same date is what puts you into placement planning and allocation. If you do not enrol on time you may not be able to continue in the unit and, if eligible, may have a delayed allocation release.

FTP + enrol due — Fit to Practice deadline. Both by this date: all FTP requirements submitted in Sonia Online, and enrolment in the unit completed.

AVA + adjustments due — One deadline covering two things: Attendance Variation Applications, which the WIL Unit actions, and Placement Adjustments, which go through Inclusion Services. Last date to submit and finalise either. Approval does not guarantee a placement; availability and capacity still apply.

Site check due — Site Check deadline. Last date to submit all Site Checks in Sonia Online if you intend to attend placement. Missing it may result in withdrawal from the unit or, where applicable, a Fail (F) grade.

Census date — Last day to withdraw from the unit without incurring the full fee. Set by the University for the whole term.

Grades published — When results for the unit are released. Informational only — no action required.

Shaded months — your placement can fall at any time within these months. Specific dates are confirmed by the WIL Unit or your supervisor closer to the time, so you must remain available for the whole period. Where a unit is offered in more than one term, each has its own row with its own deadlines — follow the row for your term.

Make-up placement. If you need additional make-up hours, these can be scheduled at any time during the year, subject to placement availability.

Dates in the 2026 column fall in 2026; all others fall in 2027. FTP and AVA deadlines do not fall in a consistent order across units — read each date individually.

This placement calendar is correct at the time of publication and is subject to change. Students must be available for the entire period during which their placement is scheduled and ensure all mandatory compliance requirements remain current and maintained throughout this period.
