If <u>NO</u>, then the ability of this student to perform at PhD level could be demonstrated through the normal PhD confirmation process without requiring additional written reports other than the confirmation document, and the recommendations of the Principal Supervisor, Director Higher Degree Research Training and the Associate Dean (Research) on this form. If a student wishes to combine the transfer and confirmation process the following is required:

- a. Supervisors, supported by their Associate Dean (Research), may nominate masters' candidates as having demonstrated the potential to be transferred to PhD enrolment. A formal recommendation with supporting documentation must be recorded with the Graduate School.
- b. Candidates so nominated will have their master's confirmation process deferred by the Faculty. Instead, they will be required to go through a PhD confirmation process of at least six and no longer than nine months of full time candidature or 12-18 months if enrolled part time.
- c. If the confirmation committee judges that the quality of the candidate's confirmation document, presentation and response to questions from the committee indicates that the candidate is capable of completing a PhD degree, then the panel can recommend a transfer to PhD enrolment.
- d. If the confirmation performance is judged to indicate capacity to complete a Masters by Thesis but not a PhD degree, then their enrolment in the masters will be confirmed.
- e. If the confirmation performance is sub-standard, the candidate will be offered the opportunity to try again in three (3) months.
- f. Following the second attempt, the outcomes could be: Recommendation to enrol in PhD candidature (i.e. transfer); recommendation to continue in a research masters (i.e. confirmation of enrolment at the current level); recommendation to withdraw from candidature (possibly enrolling in a coursework program); or termination from candidature.
