What is the School Access **Program**?

Southern Cross University Library welcomes senior secondary students to use our spaces and to borrow from our collections. The School Access Program offers secondary students in Years 10, 11 and 12 the opportunity to join and use the Library at our Lismore and Gold Coast campuses.

Becoming a member

Fill in the application form on this brochure and drop it in to your local campus. There is no charge for joining the Library. Your membership expires at the end of December regardless of the month you joined. Renew your membership at the start of each year.

Borrower's card

Your school ID card will be your library card. Please present this card when registering. If you do not have a card, an alternative will be provided.

What can you borrow?

- up to 20 items
- items can be borrowed for four weeks
- items are automatically renewed up to two times if they have not been reserved by another borrower or you have other items overdue.

What can't you borrow?

- Journals (serials, magazines and newspapers)
- **Reference Collection items**
- Textbooks required for SCU units

These items can be used in the library.

Late returns

We do not charge overdue fines. However if you do not return your item, we will email you a 'long overdue' notice and you will be billed for the replacement cost of the item. Please contact the Library if you are unable to return your items on time.

Opening hours
