• Floor Plan

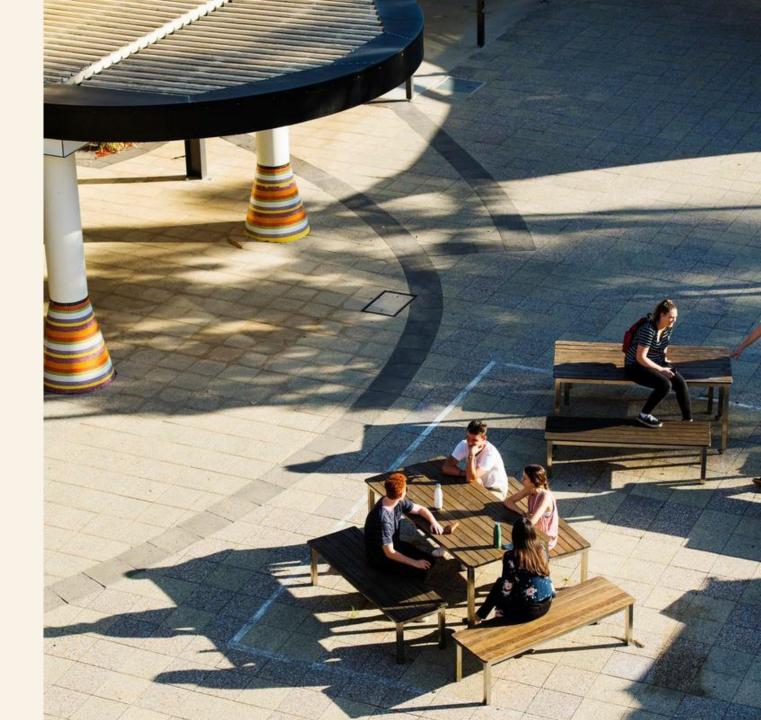


ABOUT US

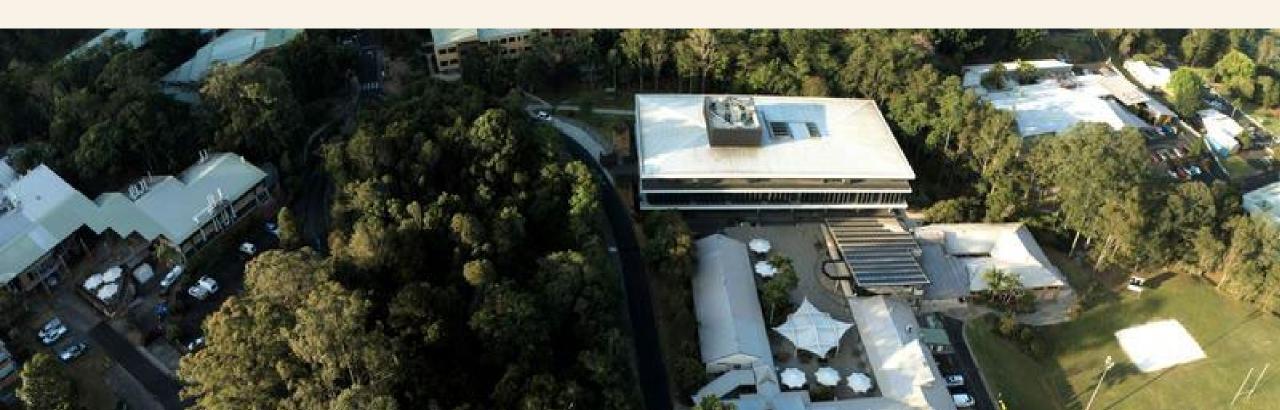

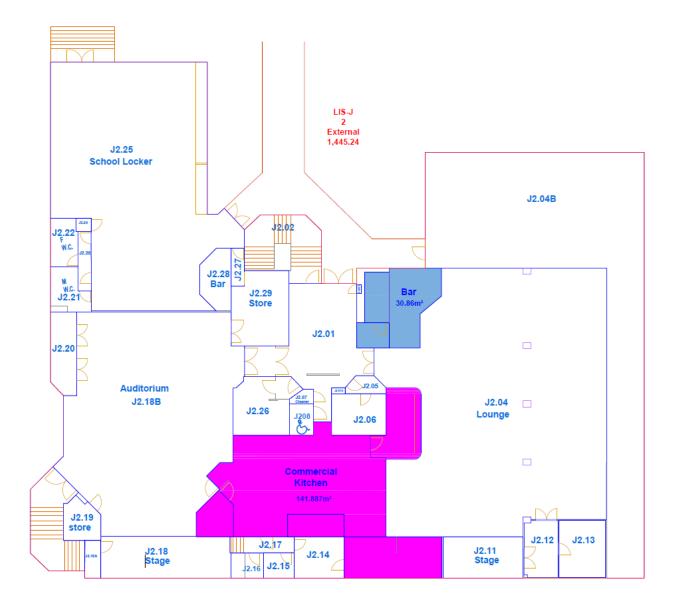


FLOOR PLAN
