Section 1: Tell us about you and your family.
Consider these questions in your response: Are you married or single? If you are married, when did you marry? What do your parents do? Do you have family living in Australia? If so, what do they do and what type of visa do they hold in Australia? How will you finance your studies in Australia? What is the annual income of your financial sponsor?
Section 2: Tell us about your spouse and children (if any). (Only answer if you are married and/or have children)

Section 3: Tell us whether you have ever held a visa to another country and whether you have ever had a visa refused or cancelled for any country, including Australia. Consider these questions in your response: Did you comply with the conditions of your visa? If your visa was refused or cancelled, what were the circumstances that led to that?
Section 4: Have there been any gaps in your study? Explain the reason for the gap. (Only answer if you have gaps of more than 3 months between your most recent study and your intended study at Southern Cross University)
Consider these questions in your response: How long is the gap between your previous study and your intended study at Southern Cross University? What was the purpose of the gap in study? What have you been doing since you completed your most recent studies?

Consider these questions in your response: How will you finance your studies in Australia? What is the annual income of your financial sponsor?
Section 6: Explain why you have chosen to study this course in Australia. Compare Australia with at least 2 other countries that you have considered. Consider these questions in your response: How will studying this course in Australia benefit your future? You should consider the cost benefit of studying in Australia compared to studying in your home country and why studying in Australia will provide you with an advantage over studying in your home country. You should also explain why you have chosen Australia over other countries outside your home country.

Section 7: Explain how this course will assist you to find employment or improve your employment propects, considering your current level of education. Consider these questions in your response: His this course relevant to your previous studies? How will this course benefit your future? Why have you chosen to study this course? Your response should show that you have clearly investigated your options and that you are aware of the benefits studying this course in Australia will provide you with. Your answer must clearly demonstrate that you are aware of the prevailing employment circumstances and expected salary in your home country for individuals with your current and anticipated educational background if you complete this course.	а
Section 8: Tell us about at least 3 other education providers you have considered and why you have chosen Southern Cross University? Consider these questions in your response: What research have you done into Australian institutes that has led you to choose Southern Cross University? Why have you chosen Southern Cross University over other institutes in Australia? What do you know about Southern Cross University? You MUST compare Southern Cross University to at least 3 other providers. Consider the course structure, location of the campus, price competitiveness, class size and any other relevant matters. Your answer must clearly indicate the level of research you have done into Southern Cross University and other providers and why you have chosen South Cross University.

Section 10: Tell us what your future plans are after you graduate from this course. Consider these questions in your response: What job do you expect to get once you complete this course? Do you have an offer of a job when you return to your home country? If not, how do you intend to look for a job once you return home?
