Our hospitality internship program is delivered through our Study Abroad program and offers you the opportunity to study and gain practical workplace experience in Australia. The program is designed so students complete one session of academic study at Southern Cross University, followed by a session of internship to build valuable 'hands on' skills and experience.

The internship session is coordinated through Southern Cross University at a tourism/hospitality organisation at a range of locations around Australia. During the internship students are provided with advice, academic supervision and mentoring by the Work Integrated Learning (WIL) team. Ongoing support and feedback on career development is also available with access to the University's employment and career information website.

Application process

1. Choose

Request approval from your home institution to participate in the Study Abroad – Hospitality Internship program at Southern Cross University. Check to see if you are eligible to receive credit for the internship with your home institution.

2. Submit

Apply online and attach all supporting documents including:

- Original or certified copies of transcripts
- English language test results; and
- Resume.

3. Accept

Once Southern Cross University has processed your application, you will receive information from your home institution.
